Examination: Sunday, 13 October 2024 Application deadline: 23:59 on Sunday, 29 September 2024 UTC +1 Central European Time (time stamp on the server of the Haydn Foundation of Bolzano and Trento will be decisive)

The Haydn Foundation of Bolzano and Trento is organising an examination-based competition for permanent recruitment to the following position in the Orchestra:

SECTION LEADER, SECOND VIOLINS (1 position) application deadline: Sunday, 29 September 2024

The competition will be held on: Sunday,13 October 2024 starting at 9 a.m. In the Auditorium Via Dante, no. 15 39100 Bolzano

Candidates are required to appear with a valid identity document. Candidates will be summoned in groups, will be told of their appointed time by e-mail and must perform in their appointed group. The programme and arrangements for the first round will be announced on the morning of the competition.

# REQUIREMENTS FOR ADMISSION TO THE COMPETITION

- a. minimum age of 18 years;
- b. Italian citizenship or citizenship of another European Union country or Schengen Area country: non-EU citizens will also be admitted to the competition provided that they are resident in an EU or Schengen Area country at the time of registration;



- c. diploma (old system) or second-level academic diploma from a State Conservatory or equivalent musical institute for the instrument being auditioned, or equivalent certification for qualifications obtained abroad;
- d. physical fitness for continuous, unconditional service in the position;
- e. enjoyment of full civil and political rights;
- f. no criminal conviction necessitating dismissal from public service employment, nor disqualification from previous employment for having obtained appointment by means of documents that were false or irrevocably invalid.

The above requirements must be met by the deadline for submitting applications. The Foundation reserves the right to verify these.

#### APPLICATIONS FOR ADMISSION

Applications for admission, written on plain, unstamped paper, clearly indicating the address and conforming to the annexed example, must be sent by e-mail no later than 23.59 on 29 September 2024 (local Italian time, UTC +1, Central European Time, with the time stamp on the server of the Haydn Foundation of Bolzano and Trento to be decisive) to the following e-mail address

Applications must be accompanied by a brief curriculum vitae (max. 20 lines) indicating the studies completed by the candidate, his/her professional and artistic qualifications and positions held, and a declaration that he/she meets the requirements of this call for applications.

The Foundation remains exempt from any liability in the event that a candidate cannot be reached at the address indicated on the application form or in the event of any failure to meet the requirements of this call for applications. Applications received after the above deadline will not be considered.

Candidates who have submitted applications will receive confirmation of their registration by e-mail. If you have not received confirmation of your registration by the closing date, you should contact the Foundation to check whether your application has been successful.

Failure to meet even one of the requirements set out in this notice, or failure to produce the necessary enclosures, will result in the candidate's exclusion from the competition. Examinations taken by candidates whose declarations prove to be untrue or inaccurate will be deemed null and void. Application for admission to the competition also implies unconditional acceptance of the final decisions of the examining board.

No allowance or reimbursement for travel or accommodation expenses will be paid to participants in the competition.

#### **EXAMINATION ROUNDS**

The examination will take place at the Bolzano Auditorium, Via Dante no. 15. Candidates who have been admitted to the examination will receive a written invitation by e-mail. Candidates must confirm their participation by replying to the invitation by e-mail and appear with a valid identification document and the complete material required for the examination programme. Piano accompaniment will be provided by the Foundation. Candidates may, however, choose their own piano accompaniment (at their own expense).



The examining board, constituted in accordance with the "*Regolamento del personale*" [staff regulations] published on <u>www.haydn.it</u>, is free to divide the examination into one or more rounds (preliminary and/or semi-final and/or final). Candidates who pass the preliminary round will be admitted to the semi-final and/or final rounds, which may also consist of several performances.

Under the "*Regolamento del personale*" published at www.haydn.it, the manner in which the examination rounds are conducted (number of rounds, use or otherwise of curtain, etc.) will be decided by the board. The assessment criteria for the examination rounds are defined by the board prior to the rounds themselves.

The board may directly admit to the semi-final and/or final rounds those candidates who have already qualified for an audition for the position in question at the Haydn Foundation of Bolzano and Trento, or who have successfully filled the position for which the competition is being held at the Haydn Foundation of Bolzano and Trento with a regular contract of employment, as well as those candidates who hold the position in question on a permanent basis (with no time limit) at other Italian orchestras (*Istituzioni Concertistico Orchestrali – ICO*) or operatic and symphonic foundations and/or permanent orchestras in foreign countries. The relevant candidates will be notified by e-mail of their direct admission (or non-admission) to the final examination.

Failure to attend the examinations will in all cases be regarded as withdrawal from the competition. The examining board has the right to require the performance of all or part of the examination programme.

Candidates who pass the preliminary round will be admitted to the semi-final and/or final rounds. At the end of the rounds, the board will establish a merit list. Candidates who, at the sole discretion of the board, voting by majority, obtain a score of not less than 9/10 will be deemed eligible for the ranking list, which will be valid for 24 months as from 25 March 2024.

Non-eligibility for a permanent position will not affect the possibility of being appointed on a fixed-term contract.

The management reserves the right to cancel the competition at any time for reasons of *force majeure*.

# ANNOUNCEMENT AND APPOINTMENT OF THE WINNER

The examining board will announce the winner of the competition on the basis of its ranking list. Such list will be valid for 24 months as from 14 October 2024 and is subject to the approval of the Foundation's board of directors, which will decide the appointment of the winner.

Interested parties will be notified of their eligibility and potential appointment within 30 days of the examination date. Following verification of the requirements set out in the call for applications, the appointment of the successful candidate will be governed by the regulations appearing in the relevant national collective bargaining agreement and in the supplementary agreement of the Haydn Foundation of Bolzano and Trento. The winner will take up her/his duties on the date indicated in the letter of appointment.

The selected candidate must notify the Foundation in writing of his/her acceptance within 15 days of his/her notification of eligibility and send the following documents on plain paper by means of registered letter to the above address, to arrive no later than the deadline indicated by the Foundation:

- a) birth, citizenship and civil status certificates\*;
- b) certificate indicating any criminal record\*;
- c) study certifications as originals or certified copies;
- d) any professional qualifications;
- e) two passport-size photographs;
- f) certificate of good health issued by the competent health authority\*.

(\*dated within the last three months)
